## **ACACIA TECHNOLOGIES ACQUIRES DIGITAL INKJET PRINTING PATENTS**

Newport Beach, CA. – (BUSINESS WIRE) August 26, 2005 – Acacia Research Corporation (Nasdaq: ACTG: CBMX) announced today that Acacia Patent Acquisition Corporation, a wholly owned subsidiary that is part of the Acacia Technologies group, a leader in technology licensing, has acquired patents relating to a technology used to improve print image quality for inkjet printers.

“Acacia Technologies has now acquired the rights to 30 patented technologies since the beginning of the year”, commented Paul Ryan, Chairman and CEO of Acacia. “We are already generating revenues from 10 of our patented technologies, and have recently initiated new licensing and enforcement campaigns for several additional technologies, to add to our revenue growth. As our success grows, we are attracting more companies and inventors that want us to license and enforce their patented technologies. We plan to continue acquiring new patent portfolios that meet our standards as we move toward our goal of becoming the leader in technology licensing” concluded Mr. Ryan.

These patents cover a method of using digital processing to create a row by row, column by column matrix of color intensity values from an image, that are stored into memory. These values are transformed using a dither matrix, resulting in enhanced color separation. Color inkjet printers are commonly used to print photo quality pictures from digital cameras.
